GROSS – Gross rate is the contractual rate of interest payable before the deduction of income tax at the rate specified by law. NET – The rate of interest which would be payable after allowing for the deduction of income tax at the rate specified by law. Interest is normally paid at the net rate, unless the account falls within an exempt category or the account holder qualifies to receive interest gross.
